

**INFORMED CONSENT FOR THE USE OF PERSONAL DATA IN COMPLIANCE WITH THE LAW

LAW 8968.**

In accordance with the provisions of Law No. 8968, Law for the Protection of the Person in Respect to the Processing of Personal Data and its Regulations, of the Republic of Costa Rica, you are hereby informed that: **(i) WORLD HUG FOUNDATION**, with legal identification number **3-006-703662**, (hereinafter the "Foundation"), has developed and implemented a database with the personal data collected through this form, this database is called [In English].
